At the August 2023 meeting, the Accrediting Commission of Career Schools and Colleges (“ACCSC” or “the Commission”) considered its previous decision to grant Welder Training and Testing Institute located in Allentown, Pennsylvania, Renewal of Accreditation for a period of five (5) years along with the school’s status as a **2022 – 2023 ACCSC School of Excellence**.¹ Based on these factors, the Commission voted to grant Welder Training and Testing Institute an additional year of accreditation.² Therefore, the school’s accreditation is now effective for a period of **six (6) years** going forward from **February 2022**.³ On behalf of the Commission, congratulations on this significant achievement.
